

USE OF NSDCA REGISTERED TRADEMARKS/LOGOS

The two trademarks or logos shown here are registered in the US Patent Office. The Association adopted the following recommendations made by our attorney at the time of registration:

- A. The NSDCA registrations are for composite marks, that is marks that encompass both words and a picture design, i.e. "National Square Dance Camper" and a log fire design; "NSD Camper" and a log fire design; both having the R in a circle. We have no protection on the use of the log fire design alone, i.e., separate and apart from the words and initials which form part of our marks.
- B. The present NSDCA registration offers protection of the sale of glassware, jewelry, clothes, etc., if sale of said items is limited to members of the NSDCA, Inc. In order to maintain and control the protection of the marks sale of such items, the general use of the NSDCA marks must be pre-approved by the Board of Directors.
- C. Upon the sale of campers, trailers, motor homes, automobiles, etc. carrying the NSDCA marks all such marks shall be removed before the sale is completed. Decals can be removed easily by gently applying heat from a hair dryer.
- D. Whenever the NSDCA marks are incorporated into a design such as chapter banners, make sure to use the entire mark including the small R in the circle.







Helpful Hints for Your RV



Some Simple Suggestions to Make Camping Easier

RV Tire Safety

RV tires, known as 'Special Trailer' or ST tires, are constructed differently than passenger or light truck (LT) tires. ST tires have thicker sidewalls that provide additional strength to help prevent the tire from rolling under the rim (due to the fixed-direction axle) when the trailer turns. All ST tires have a maximum speed rating of 65 mph.

The RV Industry Association (RVIA) is the national trade association representing RV manufacturers and their component parts suppliers who together build more than 98 percent of all RVs produced in the U.S., and approximately 60 percent of RVs produced worldwide. The RVIA has mandated changes in Original Equipment (OE) tire load capacity recommendations and design upgrades that are already showing-up on all new RV trailer models that display their RVIA membership placard.

Remember, RVIA's recommendations are voluntary and in no way binding on the RV trailer industry. There is nothing to prevent the vehicle manufacturer from just leaving the RVIA seal of approval off the trailers they manufacturer. However, any RV trailer manufacturer member that wants to remain a member is going to comply with RVIA's recommendations.

The basics are very simple: All RV trailer tires larger than 13 inches (outer diameter) must be radial designed tires.

RVIA recommends RV trailer manufacturers provide a 10% load capacity reserve above the certified Gross Axle Weight Rating (GAWR) for all OE tires. That means an RV trailer with 3500 lb. GAWR axles must have tires that that can provide 1925 lb. of load capacity when inflated to the trailer manufacturer's recommended cold inflation pressure found on the trailer's certification label.

The trailer manufacturer is still free to use the Federal Motor Vehicle Safety Standards (FMVSS) without any government repercussions. The FMVSS are a <u>mandatory</u> safety net, written by the National Highway Traffic Safety Administration (NHTSA) to insure all vehicles - including all RV trailers - are built in compliance with <u>minimum</u> safety standards.

The US Tire Manufacturers Association (USTMA) says the following about tire inflation pressures:

"Inflation pressure recommendations may be determined based on the

tire manufacturer's specifications, which define the amount of inflation pressure necessary to carry a given load. These inflation pressures may differ from those found on the vehicle tire placard or certification label."

"However, never use inflation pressure lower than specified by the vehicle tire placard, certification label or owner's manual. Nor should inflation pressure exceed the maximum pressure molded on the tire sidewall."

Pressure, tread, rotation, alignment—these are the top four when it comes to ongoing tire maintenance. Spending a little time on these essentials every month and every few thousand miles will help your tires keep you safe.

The USTMA says the following about tire care essentials:

Spending just a few minutes each month on maintenance can make all the difference in your tires' safety, life and performance. You don't need to be an expert mechanic. Just stick to the four essentials.

1. TIRE PRESSURE: Proper inflation pressure—perhaps the most important tire condition to monitor—gives tires the ability to support the vehicle and you to control it for maximum performance. Bonus benefit: Maintaining proper inflation pressure maximizes fuel economy, too.

Under inflated tires generate excessive heat build-up and stress, causing irregular wear and internal damage.

Over inflated tires are more likely to be cut, punctured or damaged when hitting an obstacle, such as a pothole.

CHECKING YOUR PRESSURE

Use a tire gauge to check inflation pressure, measured in in psi (pounds per square inch). You'll find recommended pressure for the tow vehicle's tires on a label on the driver's door or in your vehicle owner's manual; recommended pressure for the trailer's tires are on a label mounted on the front driver's side of the trailer.

And don't forget about your spares (tow vehicle and trailer).

WHEN TO CHECK

Check your tires at least once a month, and check them when they're cold—meaning parked for at least three hours. Note that inflation pressure increases (in warm weather) or decreases (in cold weather) one to two pounds for every 10 degrees of temperature change.

Also, check your pressure before you head out on any long trips, carry heavy loads or tow a trailer.

TPMS

A Tire Pressure Monitoring Systems (TPMS) detects a loss of inflation

pressure and warns the driver when tires are 25% underinflated. For many vehicles, this warning may be too late to prevent damage. A TPMS is not a replacement for monthly tire pressure checks with a gauge.

2. TREAD DEPTH: Tread equals traction—giving your tires a grip on the road, especially in bad weather. Lose too much tread and you could lose control.

Once your tread wears down to 2/32nds of an inch, it's time to visit your local tire shop. Take a few minutes each month to visually inspect your tires for uneven wear, high and low areas, unusually smooth areas and other signs of damage.

Tires have built-in tread wear indicators, or wear bars. When the tops of these bars are flush with the tire's tread, the tire needs to be replaced.

Here's a quick and affordable tread test: Place a penny upside down into a tread groove. If part of Lincoln's head is covered by the tread, you're good to go. If you can see all of his head, it's new tire time.

3. TIRE ROTATION: Rotating your tires based on the recommendations in your vehicle's owner's manual can prevent irregular tire wear. If no rotation period is specified, USTMA recommends every 5,000 to 8,000 miles.

Once you're done, make sure the inflation pressure is set to the vehicle manufacturer's specifications.

Regardless of the penny test results (see #2 immediately above) prudence dictates replacing your RV tires at least every three to five years. It's relatively inexpensive insurance to promote tire safety and minimize the potential for a blowout.

4. TIRE ALIGNMENT: Striking a pothole or other road hazard could cause tow vehicle alignment issues and bent trailer axles. Misaligned wheels can lead to uneven, rapid tread wear and should be corrected by a tire dealer. Have your alignment checked at any indication of trouble, such as "pulling," and periodically, along with your tire balance, as specified by your vehicle's owner's manual. Trailer tires should also be balanced and the axles can become misaligned; a frame shop (e.g., truck and body repair) can usually handle your trailer axles if your local RV dealer-ship can't.

Why tires fail: the answer from a tire engineer

Tires fail from two basic causes: 1) low air pressure and/or 2) long-term degradation of the rubber, usually from excess heat.

Low pressure (an active leak from puncture, loose valve stem or valve core are the most common reasons) can lead to a sidewall flex failure or more commonly called a "blowout." The sidewall cord can melt (polyester) or fatigue (steel). Many travel trailer owners fail to realize that they will never "feel" the results of a tire losing air till it is too late and they are surprised when the sidewall lets go. The rapid air loss "bang," even when the tire only has about 10 to 20 psi in it, is a big surprise IF they even hear it. A tire pressure monitoring system (TPMS) can provide warning of air loss so is good insurance and can easily pay for itself.

The long-term degradation of the rubber at the edges of the belts can lead to a belt and/or tread separation. Even if the tire keeps its air you can have this type of failure, so a TPMS will not provide a warning. This degradation comes with age as rubber is always losing flexibility. Just think of those rubber bands you found in the back of the desk drawer. Even in cool and dark they got brittle. *However*, running at, near or above the load capacity of a tire will result in increased heat generation. Running at a higher speed will also generate excess heat. Increased heat can accelerate the aging process with a doubling of the rate each increase on 18°F. Running a margin of at least 15% between capacity and the measured load is a good first step.

Realizing that over half of the RVs on the road have one or more tires or axles in overload (due to improper placement of cargo in the trailer) is one main contributor to the high tire failure rate.

Buying the lowest cost "no-name" tires is, IMO, a major contributor to poor results. If the main objective is the lowest cost tire, why would anyone be surprised with short tire life?

Just paying more, however, is no guarantee of better quality. I believe the best tool available is comparing warranty and service support. Can you get a multi-year warranty on the tires? Is it possible to get Road Hazard coverage? Is there a nationwide network of dealers who stock the brand you are considering?

Do your homework before buying new tires for your RV (and car). Read professionally-performed test results and user reviews.



NSDCA BLANKET LIABILITY INSURANCE

The NSDCA has had blanket liability insurance coverage for all its activities since August 1, 1975. We are currently buying insurance through the Lawley Vivacqua LLC Agency and are insured with the Atlantic Casualty Insurance Company.

This insurance is issued in the name of the association, all its affiliated chapters, and includes all officers and directors, of either the association or any chapter while it engages in any activity on behalf of their group. The limit of the liability is \$1,000,000.00 per incident (\$2,000,000 aggregate) for either bodily injury or property damage or both when NSDCA is negligent.

This is however **NOT** accident insurance. It covers only injury or damage caused accident or negligence of the NSDCA or its chapters in the course of their activity. It will not necessarily pay for any injury that might happen. It has to happen in such a way that NSDCA would be legally held responsible for the injury. The insurance company would investigate and defend a claim resulting from any accident, but the injured party will normally not receive a settlement unless it can be proven there was negligence or fault of the chapters or association.

The policy is issued on a comprehensive liability form that covers the activities of the NSDCA or its chapters. This includes campouts, meetings, social affairs or any other type of an event, all of which are automatically insured. Specific questions should be referred to the company agent through whom the insurance is written.

The application Forms for Insurance Certificates, are available from the NSDCA at www.nsdca.org. There is no charge for the 'Proof of Insurance' certificate and it may be obtained by contacting:


